1. Overview

Human Fibrinogen *in vitro* ELISA (Enzyme-Linked Immunosorbent Assay) kit is designed for the quantitative measurement of fibrinogen concentrations in saliva, milk, urine, and CSF samples.

A Fibrinogen specific antibody has been precoated onto 96-well plates and blocked. Standards or test samples are added to the wells and subsequently a Fibrinogen specific biotinylated detection antibody is added and then followed by washing with wash buffer. Streptavidin-Peroxidase Conjugate is added and unbound conjugates are washed away with wash buffer. TMB is then used to visualize Streptavidin-Peroxidase enzymatic reaction. TMB is catalyzed by Streptavidin-Peroxidase to produce a blue color product that changes into yellow after adding acidic stop solution. The density of yellow coloration is directly proportional to the amount of Fibrinogen captured in plate.

Fibrinogen (FBG) is a homodimer of molecular mass 340 kDa, made up of two sets of a, β , γ polypeptide chains and synthesized in the parenchymal cell of the hepatocyte and in the megakaryocyte. Fibrinogen plays a major role in coagulation and both elevated and decreased levels have clinical significance. Upon cleavage by thrombin in the initial stages of coagulation activation, fibrinogen self-assembles to yield a fibrin clot matrix that subsequently is cross-linked by factor XIIIa to form an insoluble network. Fibrinogen also binds to the platelet glycoprotein IIbIIIa receptor to form bridges between platelets, thus facilitating aggregation. Elevated plasma fibrinogen has been identified as an independent risk factor for coronary atherosclerosis and ischemic heart disease. Individuals with congenital absence of fibrinogen, termed afibrinogenemia, have prolonged bleeding times.

2. Protocol Summary

Prepare all reagents, samples, and standards as instructed

Add standard or sample to appropriate wells.

Incubate at room temperature.

Wash and add prepared biotin antibody to appropriate wells.

Incubate at room temperature.

Wash and add prepared Streptavidin-Peroxidase Conjugate. Incubate at room temperature.

Add Chromogen Substrate to each well. Incubate at room temperature

Add Stop Solution to each well. Read immediately.

3. Precautions

Please read these instructions carefully prior to beginning the assay.

- All kit components have been formulated and quality control tested to function successfully as a kit.
- We understand that, occasionally, experimental protocols might need to be modified to meet unique experimental circumstances.
 However, we cannot guarantee the performance of the product outside the conditions detailed in this protocol booklet.
- Reagents should be treated as possible mutagens and should be handled with care and disposed of properly. Please review the Safety Datasheet (SDS) provided with the product for information on the specific components.

4. Storage and Stability

Store kit at +4°C immediately upon receipt, apart from the SP Conjugate & Biotinylated Antibody, which should be stored at -20°C. Kit has a storage time of 1 year from receipt, providing components have not been reconstituted.

Refer to list of materials supplied for storage conditions of individual components. Observe the storage conditions for individual prepared components in the Materials Supplied section.

5. Limitations

- Assay kit intended for research use only. Not for use in diagnostic procedures.
- Do not mix or substitute reagents or materials from other kit lots or vendors. Kits are QC tested as a set of components and performance cannot be guaranteed if utilized separately or substituted.

7. Materials Required, Not Supplied

These materials are not included in the kit, but will be required to successfully perform this assay:

- Microplate reader capable of measuring absorbance at 450 nm.
- Precision pipettes to deliver 1 µL to 1 mL volumes.
- Adjustable 1-25 mL pipettes for reagent preparation.
- 100 mL and 1 liter graduated cylinders.
- Absorbent paper.
- Distilled or deionized water.
- Log-log graph paper or computer and software for ELISA data analysis.
- 6 tubes to prepare standard or sample dilutions.

8. Technical Hints

- This kit is sold based on number of tests. A 'test' simply refers to a single assay well. The number of wells that contain sample, control or standard will vary by product. Review the protocol completely to confirm this kit meets your requirements. Please contact our Technical Support staff with any questions.
- Selected components in this kit are supplied in surplus amount to account for additional dilutions, evaporation, or instrumentation settings where higher volumes are required. They should be disposed of in accordance with established safety procedures.
- Make sure all buffers and solutions are at room temperature before starting the experiment.
- Samples generating values higher than the highest standard should be further diluted in the appropriate sample dilution buffers.
- Avoid foaming or bubbles when mixing or reconstituting components.
- Avoid cross contamination of samples or reagents by changing tips between sample, standard and reagent additions.
- Ensure plates are properly sealed or covered during incubation steps.
- Make sure you have the right type of plate for your detection method of choice.
- Make sure the heat block/water bath and microplate reader are switched on before starting the experiment.

9. Reagent Preparation

- Equilibrate all reagents to room temperature (18-25°C) prior to use.
- Prepare fresh reagents immediately prior to use.
- When diluting the concentrates, make sure to rinse the bottle thoroughly to extract any precipitates left in the bottle. If crystals have formed in the concentrate, mix gently until the crystals have completely dissolved.

9.1 1X Diluent N

Dilute the 10X Diluent N Concentrate 1:10 with reagent grade water. Mix gently and thoroughly.

Δ Note: Store for up to 1 month at 4°C.

9.2 1X Wash Buffer

Dilute the 20X Wash Buffer Concentrate 1:20 with reagent grade water. Mix gently and thoroughly.

9.3 1X Biotinylated Fibrinogen Detector antibody

- 9.3.1 The stock Biotinylated Fibrinogen Antibody must be diluted with 1X Diluent N according to the label concentration to prepare 1X Biotinylated Fibrinogen Antibody for use in the assay procedure. Observe the label for the "X" concentration on the vial of Biotinylated Fibrinogen Antibody.
- 9.3.2 Calculate the necessary amount of 1X Diluent N to dilute the Biotinylated Fibrinogen Antibody to prepare a 1X Biotinylated Fibrinogen Antibody solution for use in the assay procedure according to how many wells you wish to use and the following calculation:

 Δ Note: Any remaining solution should be frozen at -20°C.

Where:

- C_S = Starting concentration (X) of stock Biotinylated Fibrinogen Antibody (variable)
- C_F = Final concentration (always = 1X) of 1X Biotinylated Fibrinogen Antibody solution for the assay procedure
- V_T = Total required volume of 1X Biotinylated Fibrinogen Antibody solution for the assay procedure
- V_A = Total volume of (X) stock Biotinylated Fibrinogen Antibody
- V_D = Total volume of 1X Diluent N required to dilute (X) stock Biotinylated Fibrinogen Antibody to prepare 1X Biotinylated Fibrinogen solution for assay procedures

<u>Calculate the volume of (X) stock Biotinylated Antibody required for</u> the given number of desired wells:

$$(C_F / C_S) \times V_T = V_A$$

Calculate the final volume of 1X Diluent N required to prepare the 1X Biotinylated Fibrinogen Antibody:

$$V_T - V_A = V_D$$

 Δ Note: This example is for demonstration purposes only. Please remember to check your antibody vial for the actual concentration of antibody provided.

C_S = 50X Biotinylated Fibrinogen Antibody stock

C_F = 1X Biotinylated Fibrinogen Antibody solution for use in the assay procedure

 $V_T = 3,520 \mu L$ (8 well strips or 64 wells)

$$(1X/50X) \times 3,520 \mu L = 70.4 \mu L$$

$$3,520 \mu L - 70.4 \mu L = 3,449.6 \mu L$$

 V_A = 70.4 μL total volume of (X) stock Biotinylated Fibrinogen Antibody required

 V_D = 3,449.6 μ L total volume of 1X Diluent N required to dilute the 50X stock Biotinylated Antibody to prepare 1X Biotinylated Fibrinogen Antibody solution for assay procedures

- **9** First spin the Biotinylated Fibrinogen Antibody vial to collect the contents at the bottom.
- 9.3.4 Add calculated amount V_A of stock Biotinylated Fibrinogen Antibody to the calculated amount V_D of 1X Diluent N. Mix gently and thoroughly.

9.4 1X SP Conjugate

Spin down the 100X Streptavidin-Peroxidase Conjugate (SP Conjugate) briefly and dilute the desired amount of the conjugate 1:100 with 1X Diluent N.

Δ Note: Any remaining solution should be frozen at -20°C.

10. Standard Preparation

- Always prepare a fresh set of standards for every use.
- Prepare serially diluted standards immediately prior to use.
- Any remaining standard should be stored at -20°C after reconstitution and used within 30 days.
- The following section describes the preparation of a standard curve for duplicate measurements (recommended).
- **10.1** Reconstitute the Fibrinogen Standard vial to generate a 160 ng/mL Fibrinogen **Stock Standard**.
- **10.1.1** First consult the Fibrinogen Standard vial to determine the mass of protein in the vial.
- 10.1.2 Calculate the appropriate volume of 1X Diluent N to add when resuspending the Fibrinogen Standard vial to produce a 160 ng/mL Fibrinogen Stock Standard by using the following equation:

C_S = Starting mass of Fibrinogen Standard (see vial label) (ng)

C_F = The 160 ng/mL Fibrinogen **Stock Standard** final required concentration

 V_D = Required volume of 1X Diluent N for reconstitution (μ L)

<u>Calculate total required volume 1X Diluent N for resuspension:</u>

$$(C_S/C_F) \times 1,000 = V_D$$

Example:

 Δ Note: This example is for demonstration purposes only. Please remember to check your standard vial for the actual amount of standard provided.

C_S = 800 ng of Fibrinogen Standard in vial

C_F = 160 ng/mL Fibrinogen **Standard** final concentration

 V_D = Required volume of 1X Diluent N for reconstitution (800 ng / 160 ng/mL) X 1,000 = 5,000 μ L

- **10.1.3** First briefly centrifuge the Fibrinogen Standard Vial to collect the contents on the bottom of the tube.
- 10.1.4 Reconstitute the Fibrinogen Standard vial by adding the appropriate calculated amount V_D of 1X Diluent N to the vial to generate the 160 ng/mL Fibrinogen **Stock Standard**. Mix gently and thoroughly.
- 10.2 Allow the reconstituted 160 ng/mL Fibrinogen Stock Standard to sit for 10 minutes with gentle agitation prior to making subsequent dilutions
- 10.3 Label eight tubes #1 8.
- 10.4 Prepare the 80 ng/mL **Standard #1** by adding 250 μL of the reconstituted 160 ng/mL Fibrinogen **Stock Standard** to 250 μL of 1X Diluent N and mix thoroughly and gently.
- 10.5 Add 120 μ L of 1X Diluent N to tube #2 8.
- 10.6 To prepare **Standard #2**, add 120 µL of the **Standard #1** into tube #2 and mix gently.
- 10.7 To prepare Standard #3, add 120 μ L of the Standard #2 into tube #3 and mix gently.
- 10.8 Using the table below as a guide, prepare subsequent serial dilutions.
- 10.9 1X Diluent N serves as the zero standard (0 ng/mL).

11. Sample Preparation

11.1 Urine:

Collect urine using sample pot. The sample is suggested for use at 1x, or within the range of 1x - 5x into 1X Diluent N; however, user should determine optimal dilution factor depending on application needs. Centrifuge samples at 800 x g for 10 minutes and assay. The samples can be stored at -20°C or below for up to 3 months. Avoid repeated freeze-thaw cycles.

11.2 Saliva:

Collect saliva using sample tube. Centrifuge samples at 800 x g for 10 minutes. Dilute samples 1:80 into 1X Diluent N, or within the range of 20x to 400x, and assay. The undiluted samples can be stored at -20°C or below for up to 3 months. Avoid repeated freeze-thaw cycles.

11.3 Milk:

Collect milk using sample tube. Centrifuge samples at 800 x g for 10 minutes. Dilute samples 1:30 into 1X Diluent N, or within the range of 10x - 100x; however, user should determine optimal dilution factor depending on application needs. The undiluted samples can be stored at -20°C or below for up to 3 months. Avoid repeated freeze-thaw cycles.

11.4 CSF:

Collect cerebrospinal fluid (CSF) using sample pot. Centrifuge samples at 3000 x g for 10 minutes. Dilute samples 1:200 into 1X Diluent N or within the range of 20x – 2000x; however, user should determine optimal dilution factor depending on application needs. The undiluted samples can be stored at -80°C for up to 3 months. Avoid repeated freeze-thaw cycles.

Refer to Dilution Guidelines for further instruction.

12. Plate Preparation

- The 96 well plate strips included with this kit are supplied ready to use. It is not necessary to rinse the plate prior to adding reagents.
- Unused well plate strips should be returned to the plate packet and stored at 4°C.
- For statistical reasons, we recommend each sample should be assayed with a minimum of two replicates (duplicates).
- Well effects have not been observed with this assay.

13. Assay Procedure

- Equilibrate all materials and prepared reagents to room temperature prior to use.
- We recommend that you assay all standards, controls and samples in duplicate.
- 13.1 Prepare all reagents, working standards, and samples as directed in the previous sections. The assay is performed at room temperature (20-25°C).
- 13.2 Remove excess microplate strips from the plate frame and return them immediately to the foil pouch with desiccant inside. Reseal the pouch securely to minimize exposure to water vapor and store in a vacuum desiccator.
- 13.3 Add 50 μ L of Fibrinogen standard or sample per well. Cover wells with a sealing tape and incubate for two hours. Start the timer after the last sample addition.
- 13.4 Wash five times with 200 µL of 1X Wash Buffer manually. Invert the plate each time and decant the contents; tap it 4-5 times on absorbent paper towel to completely remove the liquid. If using a machine, wash six times with 300 µL of 1X Wash Buffer and then invert the plate, decant the contents; tap it 4-5 times on absorbent paper towel to completely remove the liquid.
- 13.5 Add 50 µL of 1X Biotinylated Fibrinogen Antibody to each well and incubate for one hour.
- 13.6 Wash microplate as described above.
- 13.7 Add 50 μ L of 1X SP Conjugate to each well and incubate for 30 minutes. Turn on the microplate reader and set up the program in advance.
- 13.8 Wash microplate as described above.
- 13.9 Add 50 µL of Chromogen Substrate per well and incubate in ambient light for 15 minutes or till the optimal blue color density develops. Gently tap plate to ensure thorough mixing and break the bubbles in the well with pipette tip.
- 13.10 Add 50 μL of Stop Solution to each well. The color will change from blue to yellow.
- 13.11 Read the absorbance on a microplate reader at a wavelength of 450 nm immediately. If wavelength correction is available, subtract readings at 570 nm from those at 450 nm to correct optical imperfections. Otherwise, read the plate at 450 nm only. Please note that some unstable black particles may be

- generated at high concentration points after stopping the reaction for about 10 minutes, which will reduce the readings.
- 13.12 Analyze the data as described below.
- **13.12.1** Calculate the mean value of the duplicate or triplicate readings for each standard and sample.
- 13.12.2 To generate a standard curve, plot the graph using the standard concentrations on the x-axis and the corresponding mean 450 nm absorbance (OD) on the y-axis. The best-fit line can be determined by regression analysis using log-log or four-parameter logistic curve-fit.
- **13.12.3** Determine the unknown sample concentration from the Standard Curve and multiply the value by the dilution factor.

14. Typical Data

Typical standard curve – data provided for demonstration purposes only. A new standard curve must be generated for each assay performed.




Figure 1. Example of Fibrinogen standard curve. The standard curve was prepared as described in Section 10. Raw data values are shown in the table. Background-subtracted data values (mean +/- SD) are graphed.

15. Typical Sample Values

SENSITIVITY -

The minimum detectable dose (MDD) of Fibrinogen as calculated by 2 standard deviations from the mean of a zero standard was established to be \sim 0.81 ng/ml.

LINEARITY OF DILUTION -

Linearity of dilution is determined based on interpolated values from the standard curve. Linearity of dilution defines a sample concentration interval in which interpolated target concentrations are directly proportional to sample dilution.

Milk samples were serially-diluted to test for linearity.

	Standard degraded	Store sample as recommended
	Curve doesn't fit scale	Try plotting using different scale
	Incubation time too short	Try overnight incubation at 4°C
	Target present below detection limits of assay	Decrease dilution factor; concentrate samples
Low signal	Precipitate can form in wells upon substrate addition when concentration of target is too high	Increase dilution factor of sample
	Using incompatible sample type (e.g. serum vs. cell extract)	Detection may be reduced or absent in untested sample types
	Sample prepared incorrectly	Ensure proper sample preparation/dilution
