### INTRODUCTION

### 1. BACKGROUND

Abcam's Factor V Human in vitro ELISA (Enzyme-Linked Immunosorbent Assay) kit is designed for the quantitative measurement of Factor V in plasma, urine, milk, cerebrospinal fluid and cell culture supernatants.

A Factor V specific antibody has been precoated onto 96-well plates and blocked. Standards or test samples are added to the wells and subsequently a Factor V specific biotinylated detection antibody is added and then followed by washing with wash buffer. Streptavidin-Peroxidase Conjugate is added and unbound conjugates are washed away with wash buffer. TMB is then used to visualize Streptavidin-Peroxidase enzymatic reaction. TMB is catalyzed by Streptavidin-Peroxidase to produce a blue color product that changes into yellow after adding acidic stop solution. The density of yellow coloration is directly proportional to the amount of Factor V captured in plate.

Factor V (FV) is an essential cofactor of the blood coagulation cascade and circulates in plasma as a large single-chain glycoprotein (330 kDa). The deduced amino acid sequence consists of 2,224 amino acids inclusive of a 28-amino acid leader peptide. During coagulation, it is converted to the active cofactor FVa via limited proteolysis by thrombin, and spliced into a heavy chain (110 KDa) and a light chain (73 KDa) held together non-covalently by calcium. In the presence of a calcium ion and the phospholipid on cell surfaces, FVa and FXa form the prothrombinase complex which catalyzes the hydrolysis of prothrombin to thrombin. Thrombin in turn cleaves fibringen to fibrin which polymerizes to form a clot. FVa is readily inactivated by anticoagulant activated protein C. FV Leiden, a single amino acid mutation, renders FVa resistant to cleavage by activated protein C. It therefore over-produces thrombin and leads to excess clotting and hereditary thrombophilia disorder. Severe FV deficiency is associated with mild to severe bleeding diathesis.

### 2. ASSAY SUMMARY

#### Primary capture antibody



Prepare all reagents, samples and standards as instructed.

#### Sample



Add standard or sample to each well used. Incubate at room temperature.

### Primary detector antibody



Wash and add prepared biotin antibody to each well. Incubate at room temperature.

### Streptavidin Label



Wash and add prepared Streptavidin-Peroxidase Conjugate. Incubate at room temperature.

#### Substrate Colored product



Add Chromogen Substrate to each well. Incubate at room temperature. Add Stop Solution to each well. Read immediately.

### 3. PRECAUTIONS

Please read these instructions carefully prior to beginning the assay.

Modifications to the kit components or procedures may result in loss of performance.

### 4. STORAGE AND STABILITY

Store kit at 4°C immediately upon receipt, apart from the SP Conjugate & Biotinylated Antibody, which should be stored at -20°C.

Refer to list of materials supplied for storage conditions of individual components. Observe the storage conditions for individual prepared components in sections 9 & 10.

### 6. MATERIALS REQUIRED, NOT SUPPLIED

These materials are not included in the kit, but will be required to successfully utilize this assay:

- 1 Microplate reader capable of measuring absorbance at 450 nm.
- Precision pipettes to deliver 1 µL to 1 mL volumes.
- Adjustable 1-25 mL pipettes for reagent preparation.
- 100 mL and 1 liter graduated cylinders.
- Absorbent paper.
- Distilled or deionized water.
- Log-log graph paper or computer and software for ELISA data analysis.
- 8 tubes to prepare standard or sample dilutions.

### 7. LIMITATIONS

 Do not mix or substitute reagents or materials from other kit lots or vendors.

### **GENERAL INFORMATION**

### 8. TECHNICAL HINTS

- Samples generating values higher than the highest standard should be further diluted in the appropriate sample dilution buffers.
- Avoid foaming or bubbles when mixing or reconstituting components.
- Avoid cross contamination of samples or reagents by changing tips between sample, standard and reagent additions.
- Ensure plates are properly sealed or covered during incubation steps.
- Complete removal of all solutions and buffers during wash steps.
- This kit is sold based on number of tests. A 'test' simply refers to a single assay well. The number of wells that contain sample, control or standard will vary by product. Review the protocol completely to confirm this kit meets your requirements. Please contact our Technical Support staff with any questions.

### 9. REAGENT PREPARATION

Equilibrate all reagents to room temperature (18-25°C) prior to use. Prepare fresh reagents immediately prior to use. When diluting the concentrate, make sure to rinse the bottle thoroughly to extract any precipitates left in the bottle. Mix the 1x solution gently until the crystals have completely dissolved.

#### 9.1 1X Diluent M

Dilute the 10X Diluent M Concentrate 1:10 with reagent grade water. Mix gently and thoroughly. Store for up to 1 month at 4°C.

#### 9.2 1X Wash Buffer

Dilute the 20X Wash Buffer Concentrate 1:20 with reagent grade water. Mix gently and thoroughly.

### 9.3 1X Biotinylated Factor V Detector Antibody

- 9.3.1 The stock Biotinylated Factor V Antibody must be diluted with 1X Diluent M according to the label concentration to prepare 1X Biotinylated Factor V Antibody for use in the assay procedure. Observe the label for the "X" concentration on the vial of Biotinylated Factor V Antibody.
- 9.3.2 Calculate the necessary amount of 1X Diluent M to dilute the Biotinylated Factor V Antibody to prepare a 1X Biotinylated Factor V Antibody solution for use in the assay procedure according to how many wells you wish to use and the following calculation:

Any remaining solution should be frozen at -20°C.

#### Where:

- C<sub>S</sub> = Starting concentration (X) of stock Biotinylated Factor V Antibody (variable)
- C<sub>F</sub> = Final concentration (always = 1X) of 1X Biotinylated Factor V Antibody solution for the assay procedure
- V<sub>T</sub> = Total required volume of 1X Biotinylated Factor V Antibody solution for the assay procedure
- $V_A$  = Total volume of (X) stock Biotinylated Factor V Antibody
- V<sub>D</sub> = Total volume of 1X Diluent M required to dilute (X) stock Biotinylated Factor V Antibody to prepare 1X Biotinylated Antibody solution for assay procedures

Calculate the volume of (X) stock Biotinylated Antibody required for the given number of desired wells:

<u>Calculate the final volume of 1X Diluent M required to prepare the 1X Biotinylated Factor V Antibody:</u>

### Example:

NOTE: This example is for demonstration purposes only. Please remember to check your antibody vial for the actual concentration of antibody provided.

- C<sub>S</sub> = 50X Biotinylated Factor V Antibody stock
- C<sub>F</sub> = 1X Biotinylated Factor V Antibody solution for use in the assay procedure
- $V_T$  = 3,520  $\mu$ L (8 well strips or 64 wells)

$$(1X/50X) \times 3,520 \mu L = 70.4 \mu L$$

$$3,520~\mu L$$
 -  $70.4~\mu L$  =  $3,449.6~\mu L$ 

- $V_A$  = 70.4 µL total volume of (X) stock Biotinylated Factor V Antibody required
- $V_D$  = 3,449.6  $\mu$ L total volume of 1X Diluent M required to dilute the 50X stock Biotinylated Antibody to prepare 1X Biotinylated Factor V Antibody solution for assay procedures

- 9.3.3 First spin the Biotinylated Factor V Antibody vial to collect the contents at the bottom.
- 9.3.4 Add calculated amount  $V_A$  of stock Biotinylated Factor V Antibody to the calculated amount  $V_D$  of 1X Diluent M. Mix gently and thoroughly.

### 9.4 1X SP Conjugate

Spin down the 100X Streptavidin-Peroxidase Conjugate (SP Conjugate) briefly and dilute the desired amount of the conjugate 1:100 with 1X Diluent M.

Any remaining solution should be frozen at -20°C.

### **10. STANDARD PREPARATION**

- Prepare serially diluted standards immediately prior to use.
  Always prepare a fresh set of standards for every use.
- Aliquot remaining stock solution to limit repeated freeze-thaw cycles. This solution should be stored at -20°C and used within 5 days.
- This procedure prepares sufficient standard dilutions for duplicate wells.
  - 10.1 Reconstitution of the Factor V Standard vial to prepare a 30 ng/mL Factor V **Standard #1**.
    - 10.1.1 First consult the Factor V Standard vial to determine the mass of protein in the vial.
    - 10.1.2 Calculate the appropriate volume of 1X Diluent M to add when resuspending the Factor V Standard vial to produce a 30 ng/mL Factor V Standard #1 by using the following equation:

C<sub>S</sub> = Starting mass of Factor V Standard (see vial label) (ng)

C<sub>F</sub> = The 30 ng/mL Factor V **Standard #1** final required concentration

 $V_D$  = Required volume of 1X Diluent M for reconstitution ( $\mu$ L)

Calculate total required volume 1X Diluent M for resuspension:

$$(C_S/C_F) \times 1,000 = V_D$$

### Example:

NOTE: This example is for demonstration purposes only. Please remember to check your standard vial for the actual amount of standard provided.

 $C_S$  = 19.5 ng of Factor V Standard in vial

C<sub>F</sub> = 30 ng/mL Factor V **Standard #1** final concentration

V<sub>D</sub> = Required volume of 1X Diluent M for reconstitution

 $(19.5 \text{ ng} / 30 \text{ ng/mL}) \times 1,000 = 650 \mu L$ 

- 10.1.3 First briefly spin the Factor V Standard Vial to collect the contents on the bottom of the tube.
- 10.1.4 Reconstitute the Factor V Standard vial by adding the appropriate calculated amount  $V_D$  of 1X Diluent M to the vial to generate the 30 ng/mL Factor V **Standard #1**. Mix gently and thoroughly.
- 10.2 Allow the reconstituted 30 ng/mL Factor V Standard #1 to sit for 10 minutes with gentle agitation prior to making subsequent dilutions
- 10.3 Label seven tubes #2 6.
- 10.4 Add 180 uL of 1X Diluent M to tube #2 6.
- 10.5 To prepare **Standard #2**, add 60  $\mu$ L of the **Standard #1** into tube #2 and mix gently.
- 10.6 To prepare **Standard #3**, add 60 μL of the **Standard #2** into tube #3 and mix gently.
- 10.7 Using the table below as a guide, prepare subsequent serial dilutions.
- 10.8 1X Diluent M serves as the zero standard, 0 ng/mL (tube #6).

### 11. SAMPLE PREPARATION

#### 11.1 **Urine**

Collect urine using sample pot. Centrifuge samples at  $800 \times g$  for 10 minutes. It is suggested to assay the sample undiluted, however 1X Diluent M may be used to dilute the sample within the range 1:2-1:10, if required. The undiluted samples can be stored at -20°C or below for up to 3 months. Avoid repeated freeze-thaw cycles.

#### 11.2 Milk

Collect milk using sample tube. Centrifuge samples at  $800 \times g$  for 10 minutes. It is suggested to assay the sample undiluted, however 1X Diluent M may be used to dilute the sample within the range 1:2-1:10, if required. The undiluted samples can be stored at -20°C or below for up to 3 months. Avoid repeated freeze-thaw cycles.

#### 11.3 Plasma

Collect plasma using one-tenth volume of 0.1 M sodium citrate as an anticoagulant. Centrifuge samples at 3,000 x g for 10 minutes and use supernatants. Dilute samples 1:25000 with 1X Diluent M and assay; users should determine an optimal dilution factor based on their application needs. The undiluted samples can be stored at -20°C or below for up to 90 days. Avoid repeated freeze-thaw cycles. (EDTA or Heparin can also be used as an anticoagulant).

### 11.4 Cell Culture Supernatants

Centrifuge cell culture media at 1500 rpm for 10 minutes at 4°C to remove debris. If necessary, dilute samples into 1X Diluent M; user should determine optimal dilution factor depending on application needs. The undiluted samples can be stored at -80°C or below. Avoid repeated freeze-thaw cycles.

### 11.5 Cerebrospinal Fluid

Collect cerebrospinal fluid using sample pot. Centrifuge samples at  $3,000 \times g$  for 10 minutes. It is suggested to assay the sample undiluted, however 1X Diluent M may be used to dilute the sample within the range 1:2-1:10, if required. The undiluted samples can be stored at -80°C for up to 3 months. Avoid repeated freeze-thaw cycles.

### 12. PLATE PREPARATION

- The 96 well plate strips included with this kit are supplied ready to use. It is not necessary to rinse the plate prior to adding reagents.
- Unused well plate strips should be returned to the plate packet and stored at 4°C.
- For statistical reasons, we recommend each sample should be assayed with a minimum of two replicates (duplicates).
- Well effects have not been observed with this assay. Contents of each well can be recorded on the template sheet included in the Resources section.

### **ASSAY PROCEDURE**

### 13. ASSAY PROCEDURE

- Equilibrate all materials and prepared reagents to room temperature (18 25°C) prior to use.
- It is recommended to assay all standards, controls and samples in duplicate.
  - 13.1 Prepare all reagents, working standards and samples as instructed. Equilibrate reagents to room temperature before use. The assay is performed at room temperature (18-25°C).
  - 13.2 Remove excess microplate strips from the plate frame and return them immediately to the foil pouch with desiccant inside. Reseal the pouch securely to minimize exposure to water vapor and store in a vacuum desiccator.
  - 13.3 Add 50 µL of Factor V Standard or sample per well. Cover wells with a sealing tape and incubate for two hours. Start the timer after the last sample addition.
  - 13.4 Wash five times with 200 µL of 1X Wash Buffer manually. Invert the plate each time and decant the contents; tap it 4-5 times on absorbent paper towel to completely remove the liquid. If using a machine wash six times with 300 µL of 1X Wash Buffer and then invert the plate, decant the contents; tap it 4-5 times on absorbent paper towel to completely remove the liquid.
  - 13.5 Add 50 µL of 1X Biotinylated Factor V Antibody to each well and incubate for one hour.
  - 13.6 Wash microplate as described above.
  - 13.7 Add 50  $\mu$ L of 1X SP Conjugate to each well and incubate for 30 minutes. Turn on the microplate reader and set up the program in advance.
  - 13.8 Wash microplate as described above.
  - 13.9 Add 50 µL of Chromogen Substrate per well and incubate in ambient light for about 15 minutes or until the optimal blue colour density develops. Gently tap plate to ensure

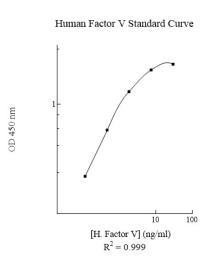
- thorough mixing and break the bubbles in the well with pipette tip.
- 13.10 Add 50  $\mu$ L of Stop Solution to each well. The color will change from blue to yellow.
- 13.11 Read the absorbance on a microplate reader at a wavelength of 450 nm immediately. If wavelength correction is available, subtract readings at 570 nm from those at 450 nm to correct optical imperfections. Otherwise, read the plate at 450 nm only. Please note that some unstable black particles may be generated at high concentration points after stopping the reaction for about 10 minutes, which will reduce the readings.

### 14. CALCULATIONS

Calculate the mean value of the triplicate readings for each standard and sample. To generate a Standard Curve, plot the graph using the standard concentrations on the x-axis and the corresponding mean 450 nm absorbance on the y-axis. The best-fit line can be determined by regression analysis using log-log or four-parameter logistic curve-fit. Determine the unknown sample concentration from the Standard Curve and multiply the value by the dilution factor.

### 15. TYPICAL DATA
